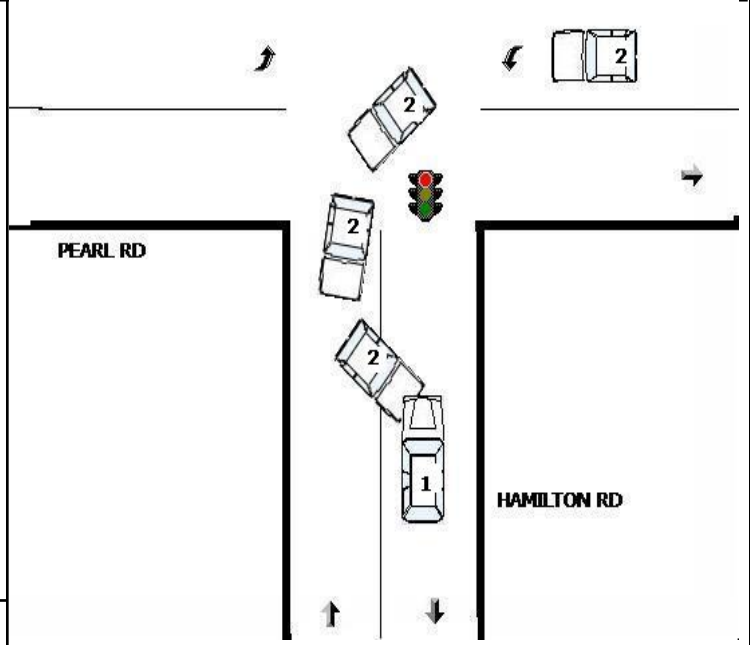

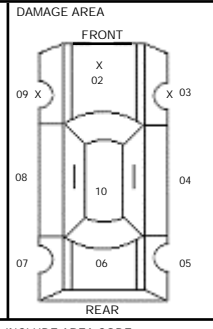
NARRATIVE


