Driver had leg/ankle injuries and was transported by Life Support Team to Medina Hospital (front airbag deployed). Vehicle towed by Lloyds. Unit two's driver stated she lost control on the snow. After striking unit one, she spun out and landed in the middle of the road, facing northeast. Unit Two complained of neck and back pain (front airbags deployed). She was transported by Life Support Team to Medina Hospital. She was found at fault and cited for marked lanes and failure to control. Heidi's towed the car.

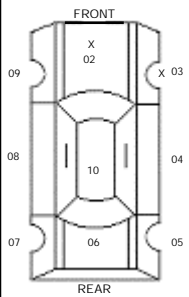
