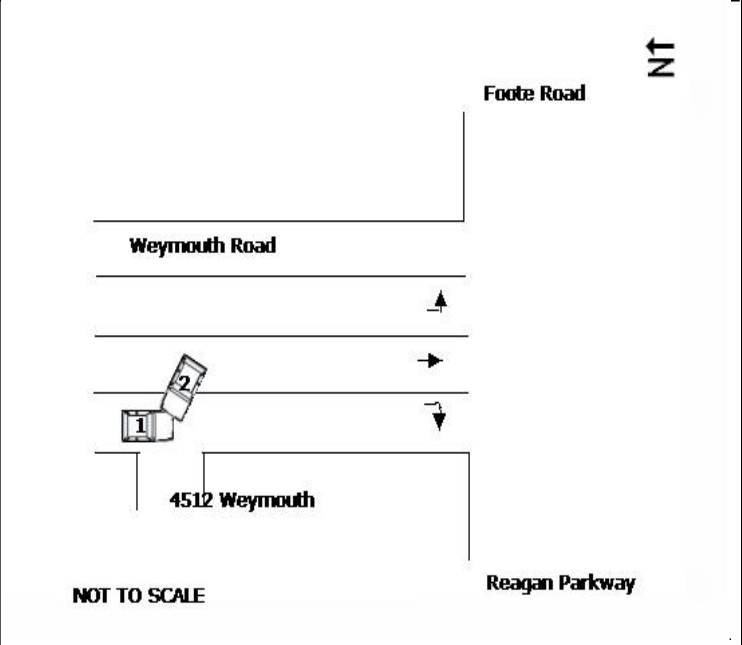


NARRATIVE


