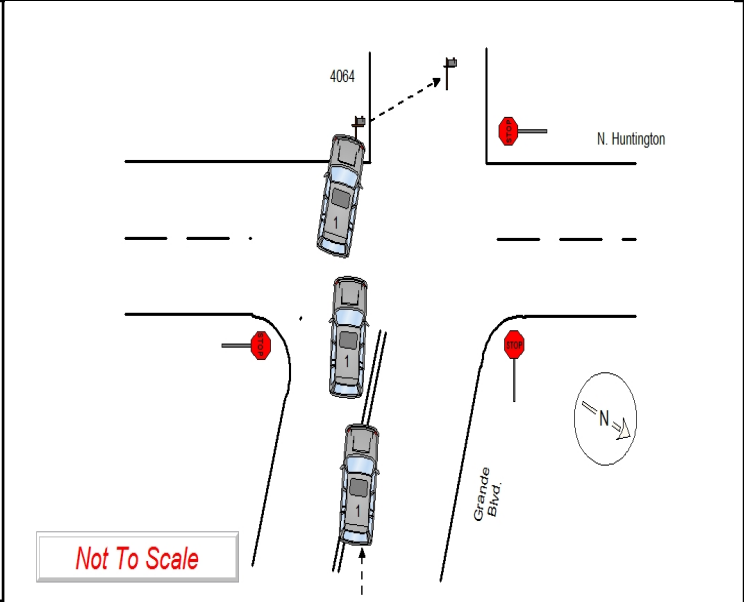

NARRATIVE

The mailbox at 4064 N. Huntington was struck sometime between 1950 and 1930 hours. A note was left on the side door of the residence with the name "Mike" and a disconnected phone number, on Bob Evans Restaurant paper. Investigation revealed that a server had left the Bob Evans two blocks from the crash around that time, and her handwriting resembled the writing on the note. An interview with the subject revealed that she had struck the mailbox, and she then provided a written statement.
