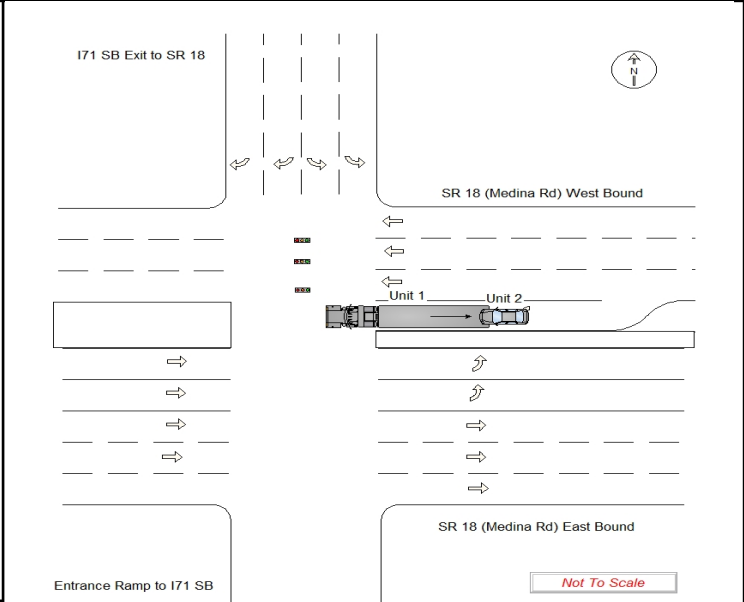

Unit One was waiting to turn left to the entrance ramp to I71 South, when he backed up. The driver of Unit One advised that he backed up and when he stopped he felt Unit Two strike him.
