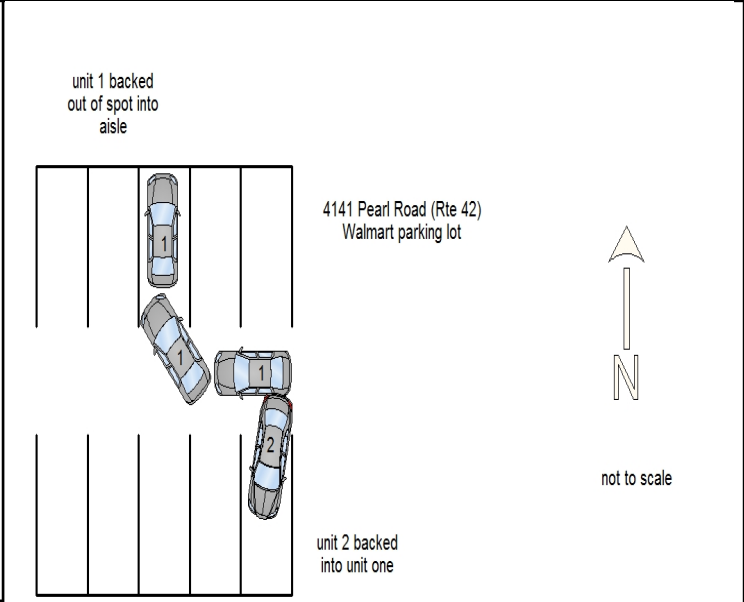
NARRATIVE

Late report of private property crash from 6-7-15. Contact was made with the owner and her daughter, the driver of unit 2 who stated on 6-7-15 she had backed out of a parking spot and was just putting into drive from reverse when a red car, unit 1, backed into her. The drivers exchanged information but didn't call the police for a report at that time. Unit 2's owner stated the driver of unit 1 is claiming her daughter hit him and he has been calling them to get his damages repaired at their expense.

I contacted unit 1's owner/driver who stated he had backed out of the spot and was in the aisle when unit 2 hit him. He sent me pictures of the damage to his car.

I obtained video from Walmart security and it showed that unit 1 was backed out and in the aisle when unit two backed into it.

Unit two found at fault for the crash. Both parties were notified of my findings on the video.
