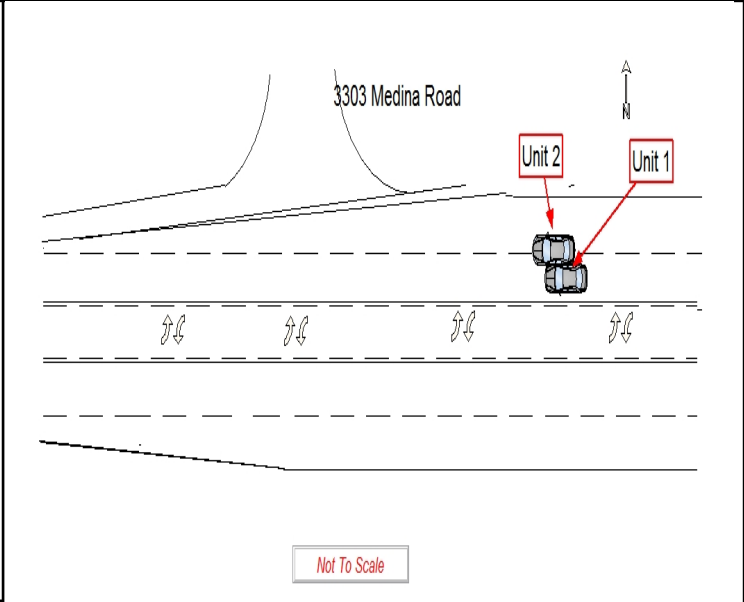
NARRATIVE
