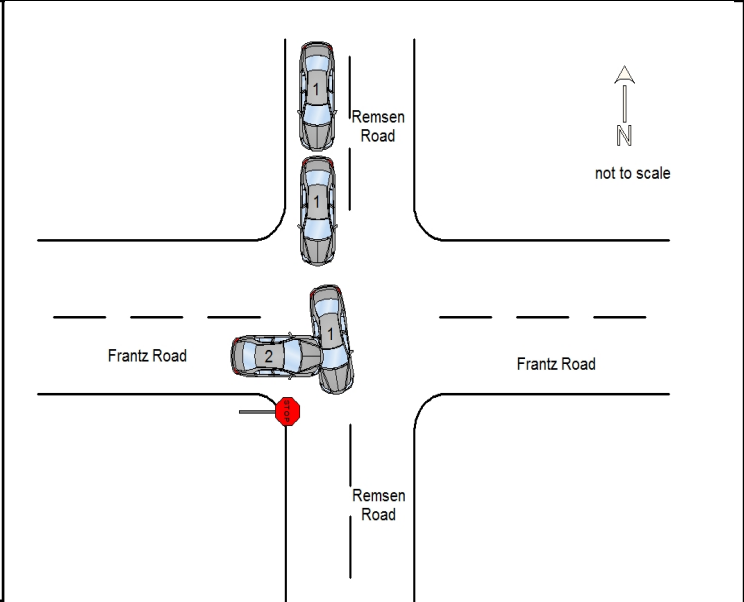

I contacted the driver of unit two via phone. She stated she left because when the dad arrived, he began screaming at her. She was afraid, so she left. I asked her what happened, she stated she was stopped at the stop sign on Frantz and looked for traffic on Remsen. She didn't see anything, so she began to pull out into the intersection. She said unit one was speeding and she wasn't able to stop before hitting unit one.

There is a slight hill on Remsen just north of Frantz; however, unit two should have still be able to see unit one approaching. The driver of unit two stated she will be back in town on Sunday and meet at the PD to fill out a statement form and provide her insurance card.

8-9-15 the driver of unit two did come on station and met with Ofc. Linsker. She provided a Geico ins. card with a start date for coverage of 8-9-15, not 8-7-15 the date of the crash. She was issued a citation.
