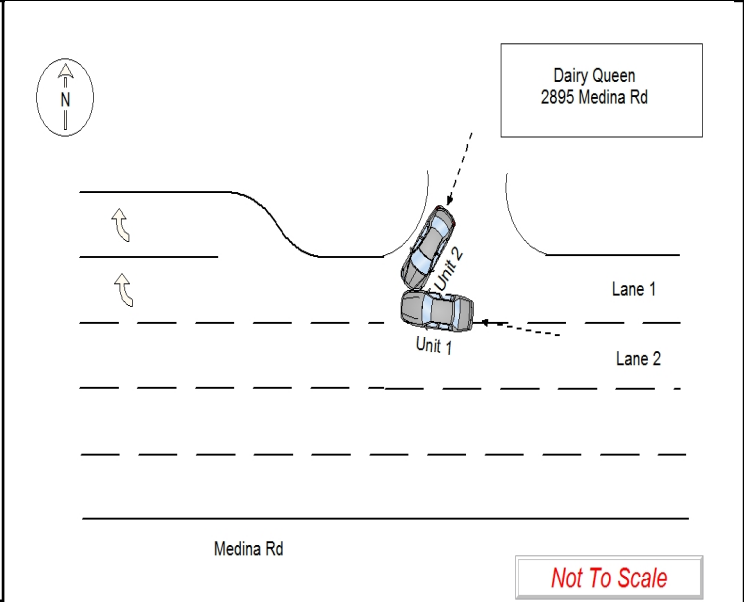

NARRATIVE

Unit #2 was exiting the Dairy Queen lot at 2895 Medina Rd, to go west on Medina Rd. Unit #1 was westbound on Medina Rd, east of the Dairy Queen exit. Driver of Unit #1 believes he was in the number 1 westbound lane; driver of Unit #2 and the independent witness state that Unit #1 was changing lanes from the number 2 westbound lane to the number 1 westbound lane. Since the investigating officer cannot determine if Unit #1 was totally occupying the number 1 lane prior to the collision, the cause of this crash is classified as unknown.
