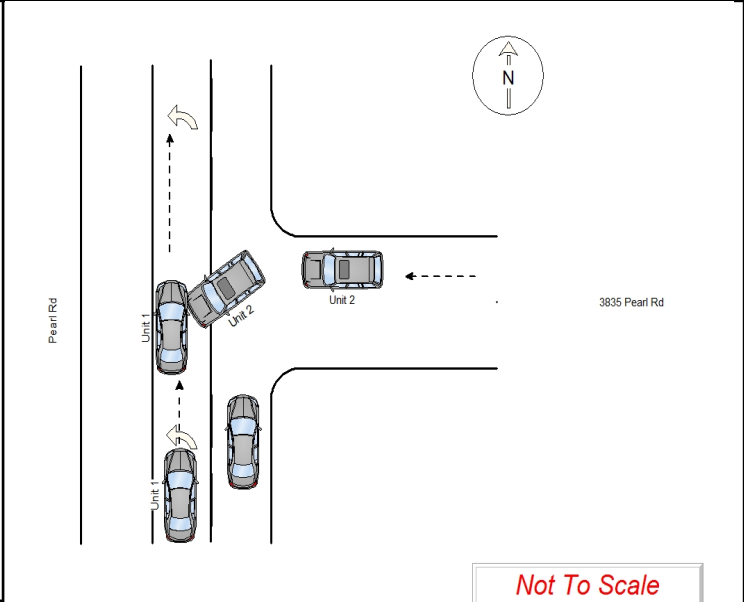

**NARRATIVE**

Unit #2 was waiting in the parking lot of Fenn Plaza, 3835 Pearl Rd., facing west, to turn south onto Pearl Rd. A vehicle in the northbound lane on Pearl Rd stopped to allow Unit #2 to turn. As Unit #2 went into the left turn lane for northbound Pearl Rd to westbound Fenn Rd, Unit #1 came northbound on Pearl Rd in the left turn lane at what was described by the listed witness and the occupants of Unit #2 as a very high rate of speed. Unit #1 struck Unit #2, and then continued northbound without stopping at the scene.
