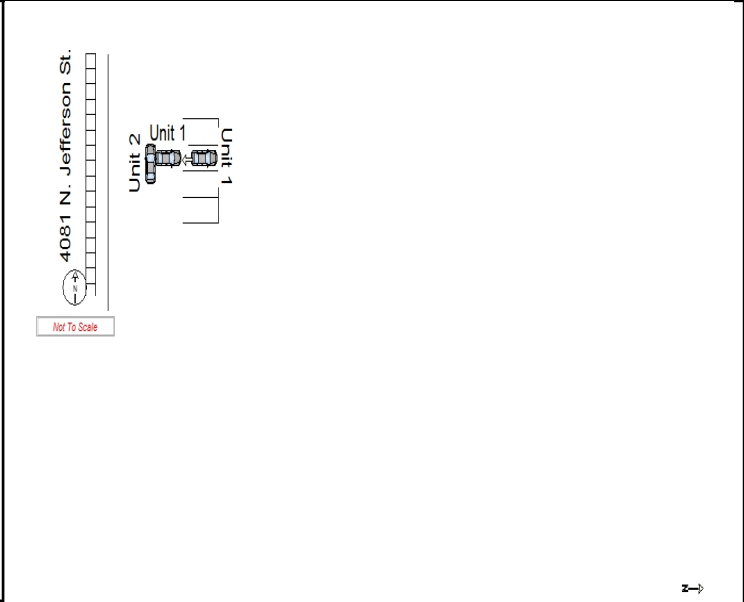

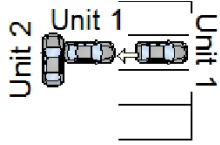
OHIO TRAFFIC ACCIDENT - OH2 DIAGRAM
