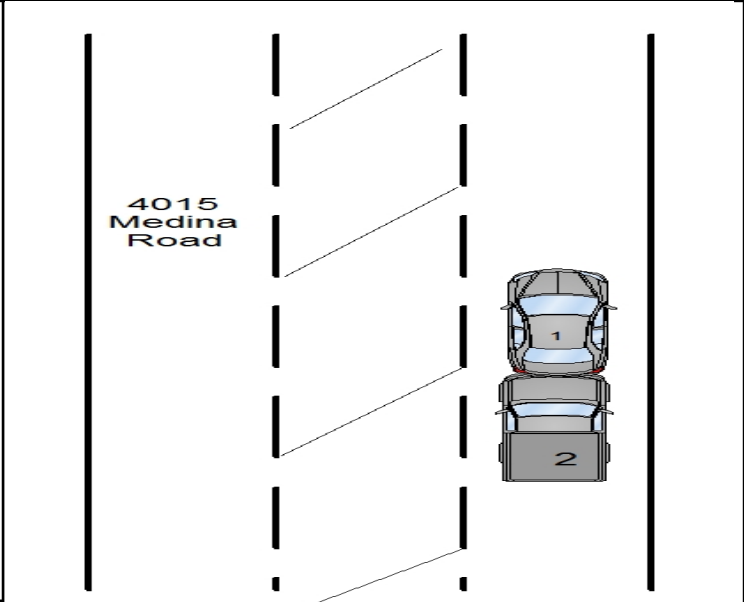
NARRATIVE


