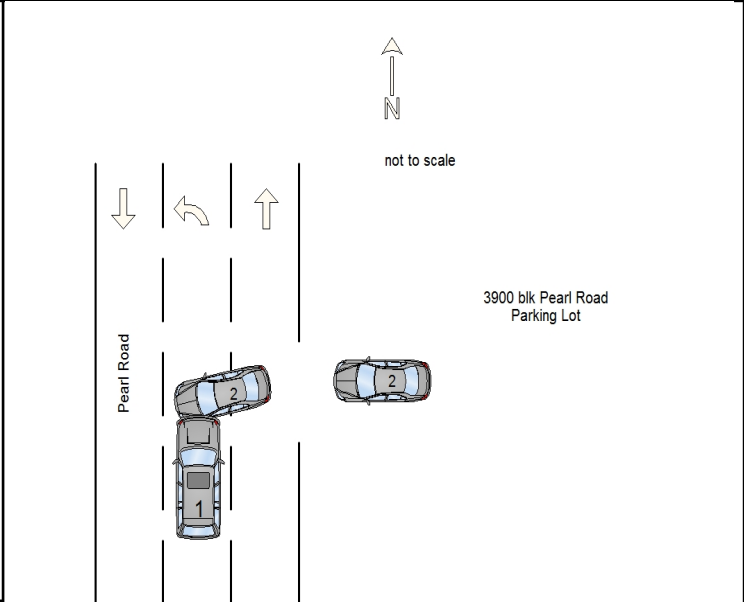

NARRATIVE

One one was traveling north on Pearl Road in the left turn lane when unit two exited a private property parking lot. Unit two made a left hand turn out of the parking lot heading south on Pearl Road. When she saw unit one coming north in the turn lane, unit two stopped and unit one, who had the right of way, couldn't stop in time and hit unit two.

No injuries to either driver. The driver of unit two stated she could barely steer the car back into the parking lot after the crash and called for a tow. Lloyds Towing arrived on scene per the driver's request. Unit one had front end damage but was driveable.

Unit two was found at fault for failure to yield out of a property driveway and issued a citation.
