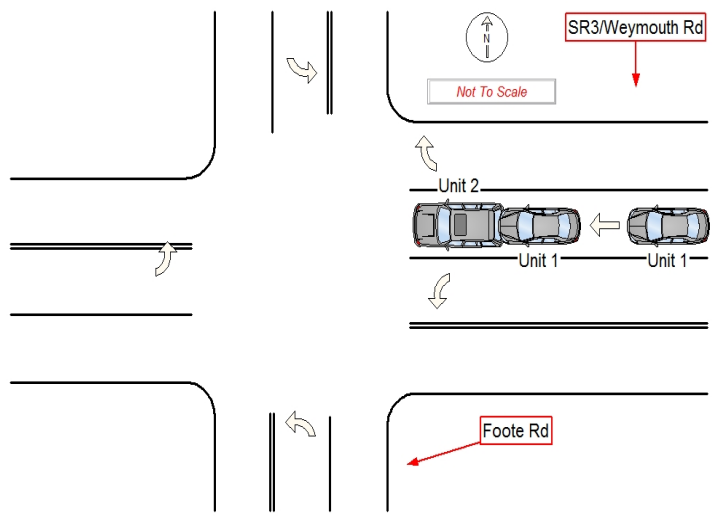

NARRATIVE Late report of a hit skip accident. Driver of Unit #2 stated they were stopped at the intersection of SR3 and Foote Rd and were rear ended by a white sedan, with a LP# of EJ20NC, who fled the scene. Driver of Unit #2 followed the white sedan to Medina High School, however the car was already parked and the driver was out of the vehicle. There was little to no damage observed on the rear bumper of Unit #2. Contact was made with the driver of Unit #1 at a later time. Driver of Unit #1 stated that Unit#2 backed into them while stopped at the intersection. Driver of Unit #1 stated Unit #2 drove off and fled the scene. Driver of Unit #1 provided a snapchat video of them driving behind what is allegedly Unit #2 after the incident occurred. Driver of Unit #1 stated there was no damage to his vehicle so they did not feel the need to report the incident. Due to conflicting stories, the late report, and little to no damage on both vehicles, fault was unable to be determined.

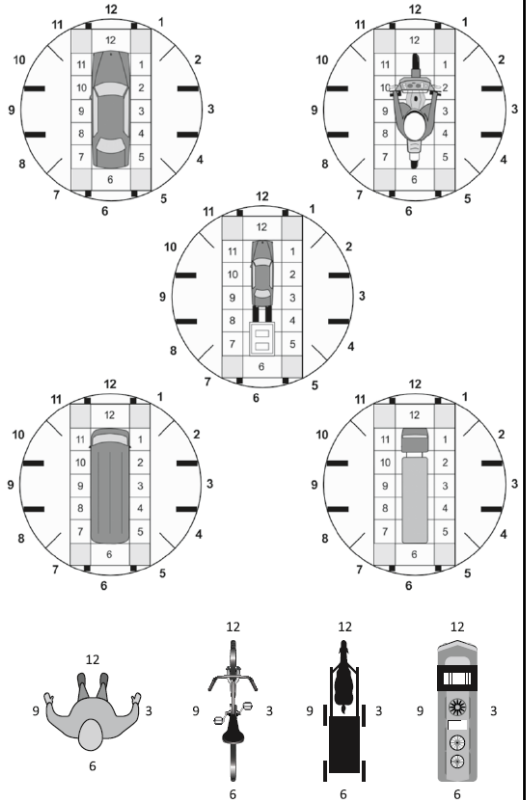
