Unit one struck unit two and continued westbound, sliding into the eastbound lane, rotating almost 180 degrees, sliding off the road to the north, and striking a tree, before coming to rest facing northeast off the roadway. Unit one had disabling damage and was towed from the scene. Unit two's rear bumper had been ripped off and was found laying in front of unit one.</p> <p>There were no injuries reported.</p> <p>Unit two found at fault for failure to yield from a private drive. The driver of unit two stated he did not see unit one.</p>

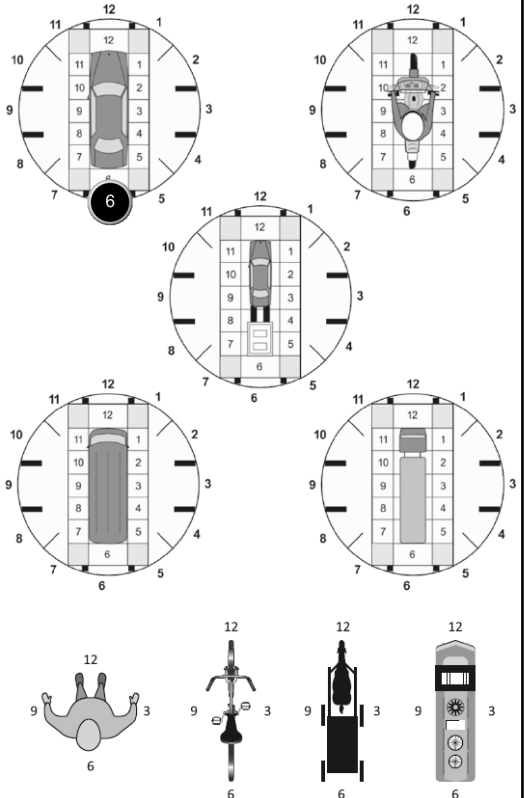
