After entering the ditch Unit 1 overturned several times before coming to rest upside down. Unit 1's driver stated he swerved to keep from striking a deer.

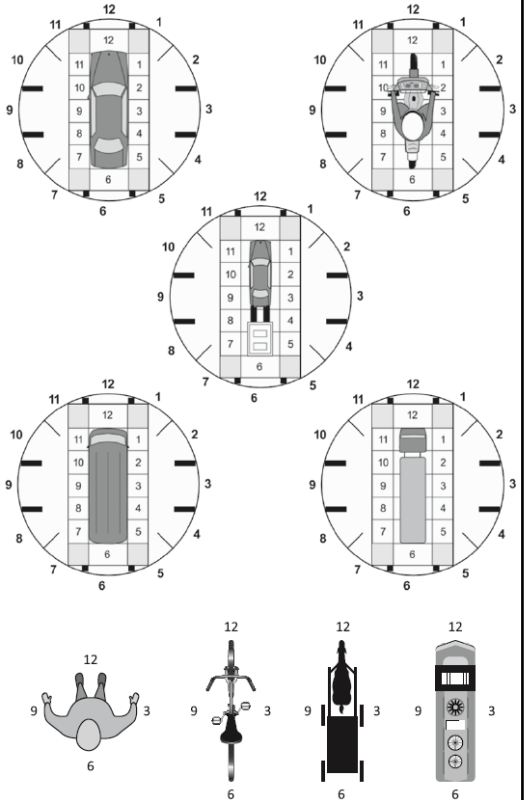
