The driver of unit two advised that he was confused about which turning lane to be in and changed lanes and was hit by the truck and pushed over the positive median barrier. Driver of unit two advised that he was a little disoriented due to hearing loss in one ear. 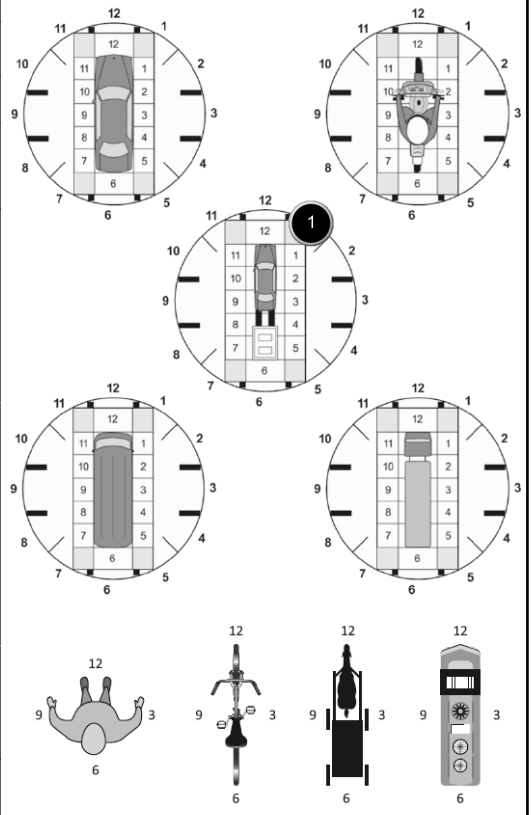

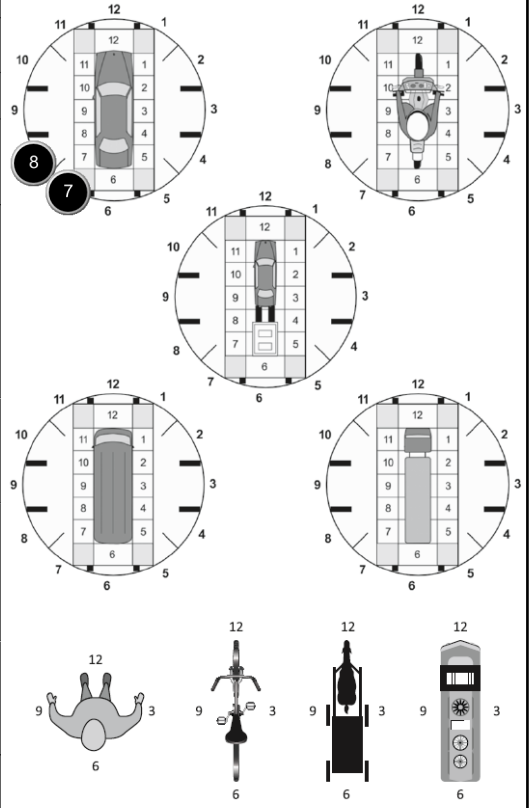
